CLOUD-NATIVE SECURITY POSTURE MANAGEMENT (CSPM): CASBs WILL INCREASINGLY INCORPORATE CSPM CAPABILITIES TO OFFER A HOLISTIC VIEW OF CLOUD SECURITY POSTURE. FOCUS ON ZERO TRUST SECURITY: CASBs WILL BE CRUCIAL COMPONENTS OF ZERO TRUST ARCHITECTURES, ENFORCING LEAST PRIVILEGE ACCESS AND CONTINUOUS VERIFICATION OF USER IDENTITIES AND DEVICES.
